**RENTAL TIMES:** 1/2 day (AM): 9:00 am - 2:00 pm. 1/2 day (PM): 2:30 pm - 7:30 pm. Full Day: 9:00 am - 7:30 pm. Week: 9:00 am first day through 7:30 pm seventh day.

**GAS:** Gasoline for this boat must be purchased at Douglas Lake Pontoon Rentals. We use Maritime fuel which is less damaging to the motor than is regular gas. Price of maritime gas will vary.

**PAYMENT SCHEDULE:** Holding fee of \$50 for half or full days and \$200 for weekly rentals is required to reserve rental dates. Full refunds granted until 1 week prior to rental date for 1/2 and full days, and 2 weeks prior for weekly rentals. Rental fee must be paid in full before renter may take possession of the boat. All rentals require a security deposit which may be paid in cash or by check. Security deposit will be returned in full upon check-out if no damage occurs during rental period. Charges for minor damages will be immediately deducted from the security deposit. Damages in excess of the security deposit amount will be invoiced, and must be paid immediately upon receipt of the invoice.

**LATE FEES:** There will be a charge of \$50.00 per hour for the late return of the boat. 5 min. to 1 hour late will be charged \$50.00, 1 hour and 5 min. to 2 hours late will be charged \$100, and so on. Late fees must be paid in full before renter leaves the premises.

**CONTENTS OF PONTOON:** Up to ten regular adult and/or four child sized life jackets (all standard—if you have a small child or large adult you may need to provide your own life jacket), flare, first aid kit, fire extinguisher, throw, map of Douglas Lake, owner's manual, other: \_\_\_\_\_

**RENTER AGREES AS FOLLOWS:**

- (1) That the pontoon is to be used solely by renter and his/her guests.
- (2) That the pontoon boat not be moved or trailered from Douglas Lake.
- (3) That renter has familiarized himself/herself with Douglas Lake and will not go into waters that are described on the provided map.
- (4) That the pontoon not be used to carry passengers for hire.
- (5) That no more than 12 passengers are allowed on the boat.
- (6) That the pontoon not be operated in a negligent manner.
- (7) That the pontoon not be operated under the influence of drugs or alcohol.
- (8) That the only person to operate the pontoon is the renter.
- (9) That the pontoon is to be operated only in daylight hours.
- (10) That the pontoon is not to be involved in any race contest.
- (11) That no other motor is to be mounted without permission of owner.
- (12) That the pontoon not tow skiers, as it is not equipped with proper motor to pull skiers.
- (13) That the pontoon will be properly moored when not in motion.
- (14) That the equipment stated as the contents of the pontoon are present and that renter is responsible for any damage or missing contents regardless of reason that occurs during the rental period.
- (15) That renter has experience as to operation of a pontoon boat and is familiar with the laws and safety requirements of operating the pontoon boat, is 18 years of age and a licensed driver of a motor vehicle.
- (16) That renter will insure that all passengers will have properly fitted life jackets on when using pontoon boat.
- (17) That renter has no mental or physical impairment that will interfere with the safe operation of the pontoon.
- (18) That renter is responsible for all damage to pontoon boat or to property of others whether he/she is negligent or the cause of the damage.
- (19) That renter is responsible for any and all injuries that occur to himself, herself, passengers or third parties during the rental period whether renter was the cause of the injury.
- (20) That renter agrees to hold harmless owner from any claim by a passenger or third party for any damage that arises from the use of pontoon during rental period including reasonable attorney fees.
- (21) Renter consents to security deposit being applied to any damage to pontoon, motor, prop, personal property of owner. That renter acknowledges he/she are responsible personally for damages above and beyond security deposit.
- (22) That the renter will purchase maritime gas from Douglas Lake Pontoon Rental LLC, and will not fill the pontoon with regular gasoline.
- (23) That if renter experiences any trouble he/she will call owner at the following numbers for any help or call **911 for emergency help. Office: 231.539.7613 Gary: 231.330.2668 Nancy: 231.330.6945**
- (24) That this agreement shall be binding on renters heirs or assigns.
- (25) That renter has read and understood the terms of the agreement and acknowledges That he/she has been instructed by owner as to the operation of the pontoon.
- (26) That further, renter acknowledges that owner is renting upon renter answering the above in a truthful manner, and that the pontoon will be returned in the condition that it was prior to renting.

Maximum occupancy limit is 12 persons.

All occupants must stay within the walls and all gates must remain closed when boat is under way.

No water skiing behind pontoon boat. No racing or negligent activities.

Boat is not to leave Douglas Lake for any reason, and must be properly moored when not in motion.

Renter is liable for all damage/accidents/injuries incurred during the rental period.
